



Frequently Asked Questions about Community Membership of NACAR

North American Conference of Associates and Religious

What is NACAR?

The North American Conference of Associates and Religious is a membership organization that acts as a catalyst to serve, empower and promote the Associate-Religious relationship. **NACAR remains the only professional organization to support and serve associates and vowed members as associates proclaim their call to live the charism of their religious communities.**

What is the purpose of NACAR?

In the early 1970's, God's Spirit began moving lay men and women to find ways to embrace and live the charisms of many religious communities in Canada and the United States of America. Groups of like-minded people, commonly known as associates, began forming, and the increase in their numbers was quite rapid. A new movement was born, one based on the mystery of call and response to the particular charism of each community's founder/foundress.

By the 1980's, leaders of many associate groups reached out to associate groups of other religious communities, both to share how the Spirit was moving with them, and to begin addressing mutual concerns. Eventually, the need to have an even wider forum developed and thus, the first North American Conference of Associates and Religious (NACAR) was created.

Who is eligible for Community Membership in NACAR?

Community membership is the backbone of NACAR. This level of membership is meant to serve the needs of Associate and Community Leadership. Membership at this level offers comprehensive services. Our membership fees are set on a sliding scale depending on the number of vowed members and associates in the Community—defined as congregation/province/region/governing unit or monastery. An Associate Community incorporated as a 501(c)3 and/or the Kenedy Directory **and** operating independently of a canonical governing unit, also qualify for *Community Membership* status.

What are the benefits of a Community Membership in NACAR?

Most importantly, it provides you with the opportunity to be part of the larger Associate-Religious movement across North America.

Benefits:

1. Discounted Individual Membership for any Vowed Member or Associate in your Community beyond your designated Listed Members.
2. Discounted fees for workshops, retreats, and conferences for all Listed Members.
3. Discounted VLCFF tuition for ALL Vowed Members and Associates in your Community.
4. Access to *Creative Conversations* for all Listed Members.
5. Access to a secure database to update your Community's information including primary contact and Listed Members.
6. Access to the Leadership Manual and other publications at a discounted rate for each Listed Member.
7. Access to Member section of NACAR website and its valuable resources to support leadership of the Associate-Religious Movement.
8. Reception of the monthly e-newsletter from the Board of Directors.
9. Reception of *The Associate* e-magazine to share with your Community.
10. A listing of your Community on our online Membership Directory.
11. A link to your Community's website from the NACAR website.
12. Networking assistance in connecting with regional Associate groups throughout North America.

What are the yearly fees for Community Membership?

Community Membership fees are on a sliding scale based on the **total number of Vowed Members and Associates in the Community**.

If the Total Number equals:	Fees are:	Number of Listed Members
125 or less	\$165	5
126 – 249	\$275	8
250 – 499	\$385	12
500 or more	\$495	15

What does Listed Members Mean?

Listed Members are designed for associate directors, community leadership, associates, communication directors or anyone in your community who has a desire to keep informed of trends, information, and resources regarding the Associate Movement in North America and also desires to support the efforts of NACAR and the Associate-Religious movement. You receive memberships based on your sliding scale fees. Listed Members **must have an email address** in order to receive communications. **A primary contact must be listed for the community. The primary contact is the first person NACAR will contact for the community regarding membership benefits, renewal or other issues.**
